#### 3. Food Truck Ordinance

Changes: Sec. 20-44 – specify during special events, food trucks are not allowed.

Add: Sec. 20-44 – Only 1 mobile vending unit will be allowed in the village on a given day, unless special permission is given by Village Council.

Add: Must not block sidewalks in any residential or commercial areas.

Add: Parking on the roads, walk up window must be faced towards the sidewalk.

Add: No parking on streets in residential areas for private parties without a permit. Residents may be allowed to have a food truck on private property without a permit provided it causes no nuisance ordinance violations for their neighbors.

Nesbitt moved Bonadurer seconded **PASSED** the motion to accept the Food Truck Ordinance with changes as discussed and set a public hearing for April 11, 2022 at 5:45 pm. 7 yeas 0 nays 0 abstain Roll Call: Bassett, Beam, Bonadurer, Nesbitt, Reinert, Selich, Slough

**4. Thumb Cell Building by Water Tower** Mr. Ratza will discuss this further with Thumb Cell and what they are offering.
